



NEXA PROVIDES UPDATE ON ATACOCHA MINE OPERATION

Luxembourg, December 22, 2020 - Nexa Resources S.A. ("Nexa Resources" or "Nexa" or "Company") (NYSE and TSX Symbol: "NEXA") informs that road access to the Atacocha mine in Peru is currently illegally disrupted due to Joraoniyoc community protest activities that have been ongoing since December 17, 2020.

While there has been no impact on Atacocha's production to date, mining production is now temporarily suspended until traffic on the road can resume.

The Company will continue to pursue active dialogue with the local community and authorities for peaceful resolution of this situation.

Nexa remains committed to the social development of its host communities and to ensuring the safety and security of its employees and contractors. Nexa will keep the market informed of further developments. The three-year production guidance remains unchanged.

About Nexa

Nexa is a large-scale, low-cost integrated zinc producer with over 60 years of experience developing and operating mining and smelting assets in Latin America. Nexa currently owns and operates five long-life underground mines - three located in the Central Andes of Peru and two located in the state of Minas Gerais in Brazil - and is developing the Aripuanã Project as its sixth underground mine in Mato Grosso, Brazil. Nexa also currently owns and operates three smelters, two located in Brazil and one in Peru, Cajamarquilla, which is the largest smelter in the Americas. Nexa was among the top five producers of mined zinc globally in 2019 and also one of the top five metallic zinc producers worldwide in 2019, according to Wood Mackenzie.
